PRESIDENT'S REPORT

The past couple of years have been very interesting. Two years ago the Society was faced with a debt of over \$12,000 and a checking account balance of less than \$6,000. Today the debt has been totally erased, the check book is healthy with over \$15,000 on hand and membership is growing. The San Diego Memorial Society is currently healthy.

A lot of the credit for our current health is thanks to you, the members. Your generous donations took care of our debt, stabilized our budget and provided for our current security. We also should note that the bequest from the Darlene Anderson estate has provided a generous endowment that will provide us with some security for some time. The Society owes a deep debt of gratitude in Darlene's memory for this great gift.

While membership is increasing, donations are down. We averaged about 24 new members a month in the past few years. In 2010 the number of new members has increased to about 45 a month. This is the result of a campaign to get the word out about the Society to all the communities of the county. It was helped by the video of our Office Coordinator, Barbara Thomson, which aired on channel 7 once and on channel 4 several times, explaining how much we help people with pre-planning for end-of-life both financially and educationally. We are slowly, but surely, losing the reputation as "San Diego's best kept secret!"

The Board of Directors you elected in April have hit the floor running. Already we have set in motion an action to acquire 501(c)(3) status. The Board's 501(c)(3) Committee recommended and the total Board approved an attorney to see the process through. Additionally, four Board members are serving on a Public Relations Committee to guide the society in utilizing

Two task forces were created: a task force to determine how to invest our inheritance in a safe and profitable manner and another one to secure a location for our annual meeting as the Unitarian church is in a remodeling mode and will not be available to us in April, 2011.

We depend upon you, our members, to do three things: First, tell your family, friends, neighbors, and your co-workers about the advantages of membership in the San Diego Memorial Society. Secondly, if you belong to any organization, club, or religious body, or live in a Senior complex encourage those in charge to consider inviting a speaker from the Society to share the great advantage of membership. Thirdly, despite the increase in new members, that income only covers about half of our expenditures. We don't want to rely on our inheritance for monthly expenses. Donations have and always will be extremely important to the work of the Society. Your support is needed just as much now as it has ever been. Please consider donating, no matter how small the amount is. And, like Darlene Anderson, consider the Society in your endowments. We help so many people in so many different ways, both with their end-of-life needs as well as educating them in all of the things available to them in their pre-planning and at-need experiences. We also advise them what to look out for that they don't need when pre-planning. We also are hoping to move into an office once again in the year ahead which will require more expenses for rent and utilities.

The Society does far more than just negotiate greatly discounted prices for your end-of-life needs. We are here to answer any questions you may have and offer our knowledge, experience and expertise in any way we can to help our members. If any problem arises with one of our Participating Mortuaries we are the one that intercedes for the family or directs them to the proper authorities.
