2014 ANNUAL MEETING

The San Diego Memorial Society will hold its' 56th Annual Meeting on Saturday, April 12th, 2014 at 1 PM. Merge onto I-15 S Take the Friars Rd Exit, EXIT7) toward Stadium. Turn left onto Friars Rd. Turn right onto Rancho Mission Rd. 10393 San Diego Mission Rd is on the left.

NORTH COUNTY I-15:

Head south on I-15 S. Take the Friars Rd exit (EXIT 7) toward Stadium. Turn left onto Friars Rd. Turn right onto Rancho Mission Rd. Turn right onto San Diego Mission Rd.. 10393 San Diego Mission Rd is on the left.

SOUTH SAN DIEGO:

Head north on CA-15 N . Take the Friars Rd exit (EXIT 7) for Friars Rd E. Merge onto Friars Rd. Turn right onto Rancho Mission Rd. Take the 2nd right onto San Diego Mission Rd.,

Proposed SDMS Bylaws Amendments 2014

ARTICLE III – BOARD OF DIRECTORS AND OFFICERS

Section 1. The governing body of the Society shall be a Board of Directors, hereinafter referred to as the Board, consisting of 7 to 15 members. *Omitted: one of which shall be the Chairperson of the Board of Trustees of the First Unitarian Church of San Diego, CA or his/her appointee, in accordance with Articles of Incorporation of the Society.*

ARTICLE VII – ASSETS

Section 2 In the event the Society disbands, or in fact ceases to function, any net assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for social welfare purposes and which has established its tax exempt status and will be selected by the Board of Directors. *Changed from: any net assets shall be given to the First Unitarian Church of San Diego, its original sponsor.*

PROPOSED AMENDMENT TO ARTICLES OF INCORPORATION OF THE SAN DIEGO MEMORIAL SOCIETY

ARTICLE 1 - NAME

1. The name of the corporation is SAN DIEGO MEMORIAL SOCIETY

ARTICLE 2 – PURPOSES AND POWERS

1. This corporation is a nonprofit public corporation and is not organized for the private gain of any person. It is organized under the California Nonprofit Public Benefit Corporation Law for public purpose.

2. The purposes for which this corporation is organized are exclusively for social welfare purposes within the meaning of Section 501(c)(4) of the Internal Revenue Code of 1986, as amended, and the Regulations promulgated thereunder as they now exist or as they may hereafter be amended (the “Code”). The specific purposes of this corporation are to study and develop methods of achieving simplicity and dignity in funeral and memorial services in order to educate and inform its members, as well as the public community at large, as to the results of such study and the benefits to be obtained thereby. Further, to assist its members in making well informed decisions in regard to making arrangements following death based upon such study.

3. The general purposes and powers of this corporation are set forth below.

- a. Notwithstanding any other provision of these Articles of Incorporation, the directors of this corporation shall not engage, participate or intervene in any activity or transaction that is not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Code or the corresponding provisions of any future United States Internal Revenue law.

- b. This corporation shall have and exercise all rights and powers conferred on nonprofit public benefit corporations under the laws of the State of California, including the powers to contract, rent, buy, or sell personal or real property.

- c. Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific and primary purpose of this corporation as described in Article 2, paragraph 2 above.

ARTICLE 3 - AGENT FOR SERVICE OF PROCESS

The name and address in the State of California of the corporation’s initial agent for service of process is:

PROPOSED AMENDMENT TO ARTICLES OF INCORPORATION OF THE SAN DIEGO MEMORIAL SOCIETY - (Continued)

ARTICLE 4 – BOARD OF DIRECTORS

The direction and management of the affairs of this corporation and the control and disposition of its properties and funds shall be vested in a Board of Directors comprised of such number of persons as may be fixed by the Bylaws of this corporation. The directors shall continue to serve until their successors are selected in the manner provided in the Bylaws of the corporation.

ARTICLE 5 - RESTRICTIONS

1. The property of this corporation is irrevocably dedicated to social welfare purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

2. Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for social welfare purposes and which has established its tax exempt status and will be selected by the Board of Directors.

ARTICLE 6 - INDEMNIFICATION

1. The liability of the directors and executive officers of this corporation for monetary damages shall be eliminated to the fullest extent permissible under the California Nonprofit Public Benefit Corporations Laws (the "Law"), including, without limitation, as provided in Section 5239 thereof with respect to volunteer directors and volunteer executive officers.

This corporation is authorized to provide for, whether by an agreement or otherwise, the indemnification of "agents," as that term is defined in Section 5238 of the Law. Notwithstanding the immediately preceding sentence, the directors and executive officers of this corporation shall be entitled to indemnification to the fullest extent permitted under, and in accordance with, Section 5238 of the Law.

2. This corporation shall have the power to purchase and maintain insurance on behalf of any agent pursuant to, and to the fullest extent permitted under, Section 5238 of the Law.

3. Any repeal or modification of this Article 6 shall be prospective only and shall not adversely affect any right or protection of a director, executive officer or other agent of this corporation existing at the time of such repeal or modification

If you answered the phone day in and day out like I do, you would realize the Society deals with people both young and elderly on a daily basis. Please continue to tell your family, friends and neighbors about the Society so our membership continues to increase.

WHO SHOULD CONSIDER A TRUST

(Who wants to avoid Probate?)

Because of the limitations in the length of the article we are asked to provide, we are making some very general statements in this article. For example, an estate with a gross value of just \$400,000.00, would generate probate fees of \$11,000.00 for attorney's fees in a simple probate. That same fee is also payable to the Executor of an estate if not waived by the Executor or Administrator. Add to this the cost of probate filing fees, referee fees, publication fees, etc. The higher the estate value, the higher the statutory probate fees will be.

It takes approximately one and one-half years for a simple probate to get through the San Diego County probate court system. Each probate is required to file an Inventory and Appraisal with the court showing all of the property of the decedent going through probate. This can include bank accounts, real property, mutual funds, stocks, bonds, etc. The inventory and appraisal is subject to public scrutiny by anyone who wants to walk in and ask to see the file. This could open up the estate to identity theft.

The State of California provides a Small Estate procedure for estates under \$150,000.00. If your total estate, real and personal property, is valued under \$150,000.00, you "generally" would not need to file a probate within the State of California.

However, if your estate is over the Small Estate amount, excluding assets highlighted below, a probate would likely be required. So, who should consider a trust:

- Anyone with an estate in excess of \$150,000.00
- Anyone who owns real property in the State of California, or elsewhere
- Anyone with minor children
- Anyone with children who are spendthrifts or who have "issues".
- Anyone who wants to control the timing and/or distribution of their gifts after death
- Anyone who wants to provide for grandchildren
- Anyone who wants to minimize or exclude estate taxes
- Anyone who wants to keep their estate private
- Anyone who wants to avoid probate costs and fees

Examples of other methods to get below the Small Estate amount: Accounts on which you can name a beneficiary to take at death are generally not subject to probate. (CD's, Savings Accounts, money market accounts); Life insurance proceeds are not subject to probate. Funds from an annuity or other tax deferred assets where you can name a beneficiary are generally not subject to probate.


REMINDER: At the time of Death...
